

Baltimore Workforce Funders - Common Performance Metrics and Definitions* **

**As recommended by the Baltimore Workforce Development Board/ Baltimore Workforce Funders Collaborative Data Workgroup (and consistent with One Baltimore for Jobs)*

***The use of these metrics and definitions is not intended to suggest that program providers should collect these data only. Programs should continue to collect additional data deemed important to provide the highest quality services to their clients/customers including data that supports case management (e.g. data on employment barriers and referrals). The BWDB and the BWFC Data Workgroup intend to develop common performance metrics and definitions for barrier removal conditions, services and/or outcomes, or Tier 2 data, after adoption of these Tier 1 data metrics.*

Enrollment	An individual who meets the eligibility criteria for a program and has remained in the program for at least three scheduled class days.	Program	Confirm whether or not the training has a “vestibule” program and, if so, the length of the program	X
Completion	An individual who has completed one or more program components or certificates that allow the participant to be employed in field for which they are training and are in the placement phase	Program		X
Credential Attainment	An individual who received an industry-recognized certificate or certification, a certificate of completion of an apprenticeship, a license recognized by the State involved or Federal Government.	Program	Verified, as possible by documentation from industry recognized body or trainer showing individual has received necessary skills or passed necessary test(s) to earn credential	X
Educational Attainment	An individual who received a GED/High School Diploma, certification through another training program or an associate or baccalaureate degree.	Program		X
Job Placement	An individual who is either a duplicated or unduplicated participant that is placed in an unsubsidized job within six months of program completion and is verified as actually having started work.
